Electronic Bidding document is available online and can be downloaded on or before **[12:00 Noon] on [2081/09/24]** for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders have to download the necessary part of bidding documents, prepare and submit their bids as specified in Instruction to Bidders. The bidder shall be required to deposit the non-refundable fee of **NRs 3000.00**, in the Revenue (Rajaswa) account as specified below and electronic scanned copy (pdf format) of Bank Deposit voucher (IFB number should be clearly mentioned) shall also be submitted along with the electronic bid files.

4. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **[12:00 Noon] on [2081/09/24]**. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2081/09/24 **at** Department of Forests and Soil Conservation, Babarmahal, Kathmandu. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **2,40,000.00**, which shall be valid for at least 30 days beyond the validity period/date mentioned in letter of bid.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
7. Bids should comply in all respects with the Instruction of Bidder included in the Bid Document. Noncompliance with this instruction will result in disqualification.
8. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
